- 7. **To receive decisions of Chiltern District Council's Planning Committee:** The recent decisions were noted.
- 8. To receive appeal notices and decisions:

i.Flowerdene, 60 Oakington Avenue. Appeal made to the Secretary of State.

ii.Land on the west side of Lodge Lane. Appeal dismissed.

- 9. **Licensing applications:** None
- 10. Waste transfer station: No further update, and topic to be removed as a standing agenda item.
- 11. Any Other Business:
 - i. A Certificate of Lawfulness had been sought for Grove Cottage, 11 Church Grove, for the insertion of a rooflight to the side roof slope. It was agreed that the Parish Council would submit 'no comment' in the recommendations.
 - ii. The date of the A404 road works and road closure was still unknown, but it was understood it would not be before September. The official diversion would be via Denham.
 - iii. A reply had been received from CDC in response to the letter sent by Don Phillips, complaining about the Planning Inspector's decision to allow building on the Chenies Parade site. The letter had been co-signed by Cllr Drew and the LCCA. The reply said that any further correspondence on the matter would not be responded to.
 - iv. Cllr Drew raised two Council issues due to the absence of a Council meeting in August. Firstly, the fencing around the Multi Use Games Area at Westwood Park had been completed. As the work had taken considerably longer than expected, owing to previous fence posts not being removed, it was agreed that the invoice should be paid immediately upon receipt. Secondly, Cllr Drew suggested a project for submission for LAF funding. Pedestrians walking from Amersham Road to the pedestrian access through to Chessfield Park have to either walk on very rough ground or, more usually, on the road which is very narrow. The Parish Council could therefore submit a bid to make this short stretch a continuation of the footpath that comes from Amersham Road which would make it much safer for pedestrians. Ideally, the east side of the road would also be widened to allow vehicles travelling in opposite directions to pass without one having to come on to the proposed footpath. It was agreed that this submission would be made. A further suggestion for LAF funding was for a new pavement alongside the previous Donkey Field, as it had now eroded. However, it was hoped that Countrywide might repair the pavement at the end of their building project, or that CDC would make the repairs. Cllr Roberts raised concerns about road safety at the corner junction of Cokes Lane and Nightingales Lane. It was noted that there had been a couple of accidents at this junction in the previous fortnight or so. It was suggested that an application could be made for LAF funding to provide

mirrors or extra signage to warn vehicles to slow down. Cllr Walford said that vegetation needed to be cut back on the corner to aid drivers' visibility. Cllr Walford agreed to check the ownership of the vegetation and to let the Parish Clerks know. It was agreed in principle to make an application for additional road safety measures for this site, but a more definite proposal needed to be drawn up.
