The Parish Council wishes to encourage and maintain a variety of shops in the village, the centre of which has an excessive proportion of eating establishments. The Parish Council does not want to lose more of the large and attractive Class A1 (shop) premises in the village. (ii) There is no justification (apparent or claimed) for a potentially 118 seater restaurant in the village. (iii) Contrary to the applicant's claim,

(iv) The Parish Council has concerns about the effectiveness of controls to minimise the potential risk of unwelcome cooking smells and noise from the proposed change of use. The Parish Council requests that, in the event that permission is granted, (i) a restriction should be made that no takeaways are allowed, and (ii) specifically if the proposed change of use for the first floor area is approved, appropriate sound proofing should be required to the walls of the premises which are adjacent to neighbour's living accommodation, to limit the impact on the neighbour's amenities. No Objection The Parish Council objects since the proposal to carry out works to the specified trees (and in particular the removal of the oak tree) conflicts with the reason that condition 5 of CH/2016/1723/FA was imposed, namely to maintain the character of the area.
