- 3. **Proposal to suspend standing orders enabling members of the public to speak:** Mrs Dealey of 25 Pavilion Way spoke to the committee concerning Planning Application – CH/2017/0750/FA for 29 Pavilion Way. The concerns were loss of privacy (as the proposed dormer windows would look into their garden) and this was the second proposed extension of the property, the first time being completed in 2014. They had previously spoken to the owner who had orally confirmed that there were no plans to use the roof space for accommodation, but this appears to be the primary reason for the current proposal. Also, the area is aimed at first-time buyers and the proposed development would not be in keeping with the area.

Appeal notices and decisions: It was noted that the decisions on Planning Application CH/2016/2141/FA Rowood Farm, Burtons Lane, Little Chalfont, HP8 4BA have gone to Appeal, the Appeal on CH/2016/1743/FA Greenview, 37 Church Grove, Little Chalfont, HP6 6SJ has been dismissed and CH/2016/2222/FA Hullavington, Burtons Lane, Little Chalfont, HP8 4BA will be heard at the Chiltern District Council's Planning Committee meeting on 1st June 2017.
- 9. Licensing applications: None
- 10. **Efes Wine and Tapas Bar:** Cllr Parker had previously informed the committee that this establishment is serving a wide range of hot food when its licence was granted on condition of limited cooking in the premises. Councillors expressed concern about the ventilation in the property. It was agreed that the Clerk would write to the owners to point out the limitation of the licence and to express concern about the adequacy of the ventilation.
- 11. **Any Other Business:** Local Plan: Cllr Ingham informed the committee that the proposal which had been circulated prior to the meeting had been approved by Little Chalfont Community Association. After discussion the committee approved the proposed course of action to appoint the specified planning consultant.
