Suspension to standing orders enabling members of the public to speak: Mrs Lovegrove and Mr Lanning spoke to oppose the application for 22 Chenies Avenue on the grounds that it would lead to more parking on Chenies Avenue, which was crowded and dangerous, serving as a busy route to Westwood Park. They favoured extension of the double yellow line along Chenies Avenue, but were advised by councillors present that the highways authority had made it clear that they would make no more changes to parking restrictions in Little Chalfont for the time being.
