Little Chalfont Park Progress so far

Activity in recent months by the team at the Hill Group on the development of Little Chalfont Park has continued to focus on obtaining the required approvals to enable construction to start later this year.

Following two public consultation events held in the village hall last year, in May and September, the Hill team submitted its first set of four reserved matters applications (RMAs) in mid-December. This covered the main access road into the site from Burtons Lane, to be known as The Avenue, and the suitable alternative natural green space (SANG).

The illustration top right shows the site of the proposed pedestrian and cyclist bridge, linking the development to Oakington Avenue.

The parish council and Little Chalfont Community Association (LCCA) undertook an extensive review of these applications, including comments made by the community in person and through the planning portal, with a joint submission made to Bucks Council at the end of February 2025.

The timeline for review by Bucks Council of the submitted RMAs is not clear at present but is likely to be delayed slightly by the upcoming council elections in May.

Nevertheless, it is expected that review of the planning applications will be concluded some time in the middle of this year, after which on-site construction activity is expected to commence.

À third public consultation event covering the fifth RMA – housing within the eastern and northern areas of the site – took place in February 2025 and the consultation period ended at the end of that month.

Once community comments have been assessed by the Hill team, a formal RMA submission will follow, probably in the coming months and, as before, this will be the final opportunity for Little Chalfont residents to comment on the applications.

Critical phase

This is now a critical phase and the Little Chalfont Park Liaison Group (LCPLG) has and will continue to hold monthly meetings with the Hill team to ensure that the community's views are represented in the developer's plans for the site.

As such, the LCPLG continues to maintain a website, (littlechalfontparkliaisongroup.co.uk) showing details of work in progress and a summary of the minutes of the monthly meetings.

Residents can also use the site to contact the LCPLG with concerns that they feel are not being satisfactorily addressed via direct contact with the Hill team.

The Hill Group will deliver a presentation on the development at the parish council annual meeting to be held on 30 April 2025.

Westwood Park

Upgrades latest

We are pleased to report that the first part of renovation of Westwood Park has been completed.

This involved clearing trees and bushes around the sports courts and the installation of new sports fencing, as shown in our picture below, and power washing equipment for the court surfaces.

This has meant that courts could

be used over the winter months, but poor weather has prevented repainting of court surfaces and lines. Weather conditions permitting, we hope to have the courts fully operational by May.

Part of this renovation is the conversion of one of

the tennis courts into two pickleball courts, one of the fastest growing sports in the country.

Once the courts are painted we plan to hold a special event with demonstrations and instructions on how to play the game. Watch out for announcements about this on the parish council website and on social media.

Next stage

Work is now beginning on plans for a new pavilion with improved facilities for sports teams and perhaps a cafe and toilets for use by the general public. We will also review how we can improve the sports pitches and drainage.

We will also be looking at the provision of a meeting/work area in

the pavilion for use by community groups. We are already in discussion with some groups, but if you are a member of a group that might use this facility, please contact the parish council.

The park will be playing its part in the Little

Chalfont centenary celebrations on Village Day on Saturday 21 June 2025, when it hosts the fun run.

We will be marking out the course for this, with white lines and distance points posts, and keeping these up for use after the event for the keen athletes, fun runners, dog exercisers and just leisurely strollers, amongst you...

Nature Park Spring is in the air

As the growing season begins after the poor weather we've had, the ongoing work of the nature park management group and its volunteers begins to show itself.

The new sensory garden has now been planted and we look forward to it growing over the coming months. The garden enables visitors to enjoy the senses from the plants across the changing seasons and provides a separate area to sit quietly.

Meanwhile, the volunteer group has been out working to ensure the rest of the park can be enjoyed as much as possible as summer approaches. In addition to clearing

We have all been busy and not noticed where four years have gone. My hope is that all the current councillors will continue to stand for election, and continue their huge contribution to the smooth running of the place where you have chosen to make your home.

Little Chalfont Centenary

We're 100 years old!

Did you know that Little Chalfont village became 100 years old on 15th January 2025?

Little Chalfont is a 20th-century creation triggered by the coming of the Metropolitan Railway. A railway station called Chalfont Road was opened in 1889 at the northernmost point of the Chalfont St Giles Parish, where the parishes of Amersham, Chenies, and Chalfont St Giles met.

At that time, the area was remote from the centres of the villages and towns, and consisted only of isolated farms and cottages, and did not have a specific name.

Metro land

The coming of the railway eventually brought local housing development, and a community developed around the station, which was renamed Chalfont & Latimer station in 1915, a name that it retains today.

In 1915 the publicity department of the Metropolitan Railway coined the term 'Metro Land' and this was depicted in the 1973 film by John Betjeman.

The first appearance of the name



Little Chalfont is in the minutes of the Chalfont St Giles Parish Council on 15 January 1925, when, at the request of the inhabitants, it was agreed that the group of houses near the station should be named Little Chalfont instead of 'Chalfont Road Village'.

For many years, Little Chalfont was split mainly in the Amersham Town Council area, and partly in Chalfont St Giles parish.

Following a period of campaigning by local residents, the village was awarded separate parish status in 2007. Most of the new parish came from Amersham, but a small part – in area rather larger in population – of Chalfont St Giles was also included.

The first chairman of the Little Chalfont Parish Council when it was founded was Mr A S H Tate who served from 2007 to 2008.

I thought I should update you on local plans in Buckinghamshire, which specify what should be built and where.

Since 2019 we have introduced new Local Plans for the former Wycombe District and all of the north of the county. In the former Chiltern District, the Local Plan is older, but the area has been very well protected as most is in the green belt and area of outstanding natural beauty (AONB).

Of course, the council has been working on a new Local Plan for all of Buckinghamshire. This was about to go out to consultation on options for future housing growth just before the general election last year.

Since then, the new government has changed virtually every aspect of local planning, with new enormous,



compulsory housing targets and the introduction of the vague concept of 'grey belt'. We also have new topdown policies requiring land for data centres, the government's industrial strategy and the so called 'Oxford to Cambridge Arc'.

As if that isn't enough, we also have the government looking at plans for a number of new towns of at least 10,500 people, many of which are being proposed for Buckinghamshire, and which will be on top of existing housing targets. The total number of houses that we will be legally required to plan to ensure are built will almost certainly be in excess of 105,000. That's equivalent to a new Milton Keynes!

All this change, and it just keeps on coming, means that we have had to scrap our previous draft proposals and go back to the drawing board for the new Local Plan.

Work on this is progressing but we do need some stability in the demands from central government before this can really move ahead.

Local elections coming up

We are holding local elections on Thursday 1 May 2025 for Buckinghamshire Council and councillors to town and parish councils where these are being contested.

Please do make sure that you are registered to vote and that you're ready to take your voter ID to the polling station with you.

Little Chalfont Farmers Market A valuable local resource

As many of you will know Little Chalfont has its own farmers market, part of Thames Valley Farmers Markets, held in the village hall car park on the second Saturday of each month.

Most of the food and drink sold at the market is produced within a 30 mile radius of the market, which means that you can be sure you are buying products from the people who have grown, reared, baked and made them, all to the highest standards.

Buying at farmers markets helps to support local farmers and producers – there are no middlemen involved.

Here we profile another regular individual stallholder:

Kitchen Preserves

Mike Allison, the proprietor of Kitchen Preserves, started the business in 2017 with his wife Gillian. Gill was a chef for 40 years before setting up this business from her own kitchen.

All Kitchen Preserves' jams, marmalades, chutneys, pickles and relishes are handmade by Gillian, using only traditional, domestic methods and simple, natural ingredients.

All of the fruits and vegetables used are grown as locally as is possible and are freshly picked. They are then

hand cut, hand stirred and poured, before each jar is hand filled and capped the old fashioned way.

Using only fresh seasonal produce captures all the flavours, colours and textures in a wide selection of family recipes blended with innovative new ideas.

All Kitchen Preserves' produce is also free from artificial preservatives, colourings and additives.

Roger Funk 1942 - 2025

The LCCA is sad to report the death last month of our former chairman, Roger Funk. Roger was a conscientious and hard working chairman from 2010 until 2024.

He increased our profile in the village and exemplified the importance of working in partnership with local bodies and of communication in the village.

Roger led objections to planning applications where appropriate and where there would have been negative impact on Little Chalfont.

He played a leading role in the campaign against development of the former golf course and, while this development goes ahead, his work has underpinned the liaison activities with the developer to ensure the best outcome for the village. Roger ensured the continued delivery of Christmas lights, hanging baskets, Village Days and a twice yearly newsletter. Under his leadership the LCCA initiated projects that contributed significantly to our community.

This included spearheading the purchase of the sculpture field, which became the Little Chalfont Nature Park.

He also chaired the Little Chalfont Charitable Trust that was set up to manage the park and oversee its future development into the beautiful space it is today. He had the vision, also, to lead the creation of the Café 22 dementia café.


